There had been very good discussions and great attendance at the meeting with approximately eighty (80) people from the Public present.

Russell that the Manitoulin Planning Board deems it appropriate to adopt Zoning By-law No. 2022-05 for the Unincorporated Townships of Dawson and Robinson, District of Manitoulin, consisting of Schedules B1, B2, B3, and B4 and explanatory text, with a few grammar corrections and rewording of Section 3. - Shoreline Vegetation Buffer - for clarification,
- Carried Unanimously.
